Selection Process for a Post-Doctorate Grant in the Post-Graduate Program in Experimental Psychology

The graduate program in Experimental Psychology at the Institute of psychology of the University of São Paulo (PPG PSE-IPUSP) publishes the opening of applications for the selection process for a grant associated with the National Program of Post-Doctorate/CAPES (PNPD/CAPES http://www.capes.gov.br/bolsas/bolsas-no-pais/pnpd-capes).

- 1. Applications
- 1.1. Candidates may enroll in one of the following modalities:
- a) Brazilian or foreign citizen resident in Brazil and carrying atemporary visa, without fixed employment (up to 60 months);
- b) Foreign citizen resident abroad, without fixed employment. Must prove residential address abroad at the time of submission of the application (up to 60 months).
- c) Professor or researcher in the country with a permanent employment in another higher education institution or public research institution. (article 5 of the regulation the PNPD/CAPES; up to 12 months).
- 1.2. The applicant should submit the following documents scanned and saved in pdf format to the email: ppg.pse@usp.br
 - Application form, duly completed. Click here for the Application form.
 - Research project to be developed. The candidate may indicate the supervisor of the project (docente responsável), or the CCP PSE will indicate the supervisor later (in this case, stipulate in the project and indicate the Coordinator of the program as responsible), if he is selected.  - The project can be written in Portuguese or English. The applicant must include, in addition to the
 research project, potential teaching activities, supervision (undergraduate and graduate) and extension to
 be developed. The courses offered by the program can be found at the following address:

 - Curriculum Lattes (http://lattes.cnpq.br/) updated or, in the case of foreigners, the annex III of the Portaria No. 086 from July 2013 03 (http://www.capes.gov.br/bolsas/bolsas-nopais/pnpd-capes). The publications of the last three years (2015-2018) should be sent in pdf format.
 - Two recommendation letters (with amongst others details: details of the connection between the
 candidate and the author, number of years of collaboration/supervision, evaluation in relation to other
 collaborators, ability to lead an independent research project), addressed directly by the author to the
 Secretariat of the PPG in word format (.docx) or pdf (ppg.pse@usp.br) with the e-mail subject:
 PNPD/CAPES PSE 2018 recommendation + full name of candidate
 - copy of RG, RNE, or passport
 - copy of CPF for residents in Brazil
 - copy of a document certifying your Ph.D. diploma.
- 1.3. Applications will be received by email, during the period from 15 September to 31 October 2018. On the 15 of November, the list of inscriptions approved will be disclosed on the site www.ip.usp.br/.
- 2. Selection process
- 2.1. The selection process will consist of an evaluation of the research project, the letters of recommendations and an analysis of the curriculum.
- 2.2. The selection process will be conducted by professores designated by the Coordination Committee of the graduate program in Experimental Psychology, which will use the same criteria as funding agencies (CNPq and FAPESP), taking into account the quality of the project and the curriculum of the candidate for the grant. The result of the selection process will be communicated until November 15, 2018 on the website www.ip.usp.br/.

- 3. The Grant
- 3.1. A grant worth a monthly valor of 4,100.00 R\$ will be provided by the PNPD/CAPES
- 3.2. For the grants approved in the modalities "a" and "b" of the art. 4, item V, the duration of the grant will be 12 months and may be renewed annually until it reaches the maximum limit of sixty (60) months.

The annual renewal will depend on the approval of an annual report presented by the grantee on the first day of the eleventh month after the starting date or of yearly renewal. The report will be reviewed by reviewers designated by the CCP and will include:

- List of publications and productions
- · Activity report
- Scientific report
- Supervision
- Detailed work plan with timeline in the event of a renewal

For successful applicants in the modality C, according to the art. 4, item V, the maximum period of duration of the grant will be of 12 months, without any possibility of renewal.

- 3.3. The CAPES can provide resources for consumables for the execution of the project.
- 4. Grantee's obligations:
- 4.1. To devote him/herself fully to the activities of research, teaching, and, if necessary, extension detailed in the research project.
- 4.2. Provide the documents required for the grant concession, whether requested by the granting agency and/or by the Secretary of the PPG/PSE-IPUSP, to enroll within the prescribed time limit.
- 4.3. To fulfill other obligations laid down by the Regulation of the national program of post-doctorate (http://www.capes.gov.br/images/stories/download/legislacao/Portaria_86_2013_Regulamento_PNPD.pdf) and the department and commission of research of the Institution (IP-USP).

Note: failure to observe the obligations can result in the loss of the grant after the assessment of the Coordination of the graduate program in Experimental Psychology.
